THE MULTI-DISCIPLINARY/CULTURAL SHELTER STAFF PROVIDES CULTURALLY COMPETENT TRAUMA INFORMED SERVICES 24 HOURS PER DAY, 365 DAYS PER YEAR. LAST CALENDAR YEAR, RUBY'S PLACE PROVIDED OVER 290 WOMEN AND CHILDREN WITH EMERGENCY SHELTER AND SPPORT SERVICES WHILE MAINTAINING 98% OCCUPANCY AT THE SHELTER. RUBY'S PLACE ALSO HAS A SECOND EMERGENCY SHELTER WHICH IS A 6 BED FACILITY FOR MALE VICTIMS OF LABOR TRAFFICKING. WE HAVE A 24-HOUR CRISIS LINE, OFFER CASE MANAGEMENT, THERAPY, CHILDREN'S PROGRAM AND A HOUSING FIRST RENTAL SUBSIDY PROGRAM AND SUPPORTIVE TRANSITIONAL HOUSING PROGRAM. OUR COMMUNITY OFFICE OFFERS DROP IN CASE MANAGEMENT SERVICES, PRESENTATION AND TRAININGS TO THE COMMUNITY.
